Councilmember Dowe expressed her appreciation of the Fire Department for hosting the 9/11 event at Fluor Field.

16. NEW BUSINESS – (Resolution – First and Final Reading)

- a. Resolution to approve a Memorandum of Understanding between the city of Greenville and United Community Bank for the design and construction of public improvements on Falls Street, East Camperdown Way, and Church Street Access Ramp
(Presented by Assistant City Manager Shannon Lavrin and Economic Development Director Merle Johnson)

Councilmember Gibson moved, seconded by Councilmember Brasington, to approve first and final reading.

Assistant City Manager Shannon Lavrin advised United Community Bank (UCB) is anticipated to create 200 new jobs along with a relocation of approximately 100 employees. Ms. Lavrin referred to incentives provided by the South Carolina Department of Revenue and South Carolina Department of Commerce that must be met by UCB. Economic and Community Development Director Merle Johnson stated the company cannot receive the incentive unless they meet the requirements. As for promotion of the new jobs, Mr. Johnson advised UCB and ReadySC have already begun the process.

Ms. Lavrin provided river views as requested by Councilmember Dowe and commented on tree ordinance requirements and potential tree planting replacements. Ms. Lavrin advised the building will be seven stories tall with the first three stories providing for parking.

After discussion, the motion carried unanimously.

17. STAFF REPORTS

- a. Police Department - Neighborhood Engagement Team
(Presented by Police Chief Howie Thompson)

Police Chief Howie Thompson provided information regarding the Neighborhood Engagement Team (NET) pilot program and stated its purpose is to build relationships and trust and to take a more wholistic approach in safety and in working with them. Chief Thompson also provided some examples of improving communication, providing better assistance and developing relationships within the neighborhoods. Chief Thompson advised that NET staffing will initially include one sergeant, one community outreach officer, and six area NET officers. Chief Thompson referred to the call areas and neighborhood assignments scheduled to date and advised officers will attend neighborhood association meetings as part of their engagement. Chief Thompson stated they look forward to growing the program and adding additional neighborhoods.

Councilmember Gibson expressed his appreciation for the program, however, he stated he would like to create real trust in the neighborhoods whereby the beat officers and NET officers both have relationships with a neighborhood so when judgment calls need to be made regarding an issue, there is a partnership between them all.

- b. City Manager John McDonough introduced and presented a video promoting the Planning Department and the Greenville Development Code process.
